# **Shipping Campaign**

Comprehensive Shipping Campaign Report distributed and discussed.

National Council of The Maritime Union of Australia (Union) hereby resolves to:

- i. Endorse the Shipping Campaign Report
- ii. Recognise the successful Blue Water Shipping Conference (BSC)and endorse ongoing work in this space
- iii. Note the Industrial matters as reported
- iv. Continue with the Policy and Lobbying work as recommended in the report and expand this work into other policy areas that essential support the need for Australian Shipping
- v. Continue work to engage ALCOA, BP, Caltex, etc to keep direct pressure on them to support a domestic shipping policy and to engage Australian seafarers on the Australian coast
- vi. Broaden out the union's policy work to include other policy areas that either support directly, or indirectly Australian Shipping policy
- vii. Continue to work with the ITF and affiliates on the Cabotage Taskforce and in particular seek research into the recent Canadian legal Settlement between the SIU Canada and the Canadian Government. The research will look at similarities between the Canadian legal settlement and Australian law to see if there is anything that can be taken from the settlement and applied in Australia.
- viii. Endorse the National Secretary to use whatever resources necessary to defend the union and the nine members sacked by ALCOA, from aggressive legal litigation by the FWO.
  - ix. Endorse a political campaign that supports the crew of the MV Portland legal defence and raises awareness of the politicisation of a government

- office by the Turnbull Government, including the making of a short DVD that tells the MV Portland Crew members story.
- x. Endorse the reformation of the Jobs Embassy in Canberra during budget week and expanding the role of the embassy to engage with the Union movement via the ACTU
- xi. Endorse the continuous campaigning strategy as outlined at this and previous National Councils to ensure we remain focused on retention a domestic shipping fleet and expansion into the future
- xii. Endorse engagement with Australian Navy to explore possible employment opportunities for Australian seafarers and report back to next National Council
